Sector consumption volumes declined with a CAGR of 0.004% between 2017 and 2022, to reach a total of 5.7 billion FTK in 2022.

The International segment accounted for sector's the largest proportion in 2022, with total revenues of \$5.7 billion, equivalent to 100% of the sector's overall value.
