The Dutch construction industry had total revenues of \$145,569.7 million in 2022, representing a compound annual growth rate (CAGR) of 5.6% between 2017 and 2022.

The residential construction segment accounted for the industry's largest proportion in 2022, with total revenues of \$77,342.3 million, equivalent to 53.1% of the industry's overall value.

According to in-house research, consumer price inflation in the Netherlands in 2022 stood at 11.4%, up from 2.6% in 2021. After a shaky 2022, the economy is predicted to stabilize in 2024, despite the unexpected and quick increase in



rates.
