The Dutch jewelry & watches retail market had total revenues of \$2.3 billion in 2022, representing a compound annual growth rate (CAGR) of 1.9% between 2017 and 2022.

The accessories segment accounted for the market's largest proportion in 2022, with total revenues of \$1.2 billion, equivalent to 51.2% of the market's overall value.

According to in-house research, in 2022, the Netherlands accounted for 2.8% of the European jewelry & watches retail market.
