#### SUMMARY

The Nigerian Construction industry had total revenues of \$133.8bn in 2021, representing a compound annual growth rate (CAGR) of 25% between 2016 and 2021.

The Non-Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$103.2bn, equivalent to 77.1% of the industry's overall value.

Containment measures and COVID-19 prevention efforts added significantly to the costs incurred by transporting companies which further reduced the incentive to build throughout the year, despite this, the market continued to grow



strongly.
