SUMMARY

The G8 Non-Life Insurance industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value 2016-20, and forecast to 2025). KEY HIGHLIGHTS

The G8 countries contributed \$2,285.2 billion in 2020 to the global non-life insurance industry, with a compound annual growth rate (CAGR) of 1.7% between 2016 and 2020. The G8 countries are expected to reach a value of \$2,714.1 billion in 2025, with a CAGR of 3.5% over the 2020-25 period.

Among the G8 nations, the US is the leading country in the non-life insurance industry, with market revenues of \$1,742.5 billion in 2020. This was followed by Germany and Japan, with a value of \$128.6 and \$109.5 billion, respectively.

The US is expected to lead the non-life insurance industry in the G8 nations with a value of \$2,054.1 billion in 2016, followed by Germany and Japan with expected values of \$155.5 and \$125.6 billion, respectively.
