### SUMMARY

Non-Life Insurance in the United Kingdom industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). ### KEY HIGHLIGHTS

The non-life insurance market consists of the general insurance market segmented into motor, property, liability and other insurance. The other segment is made up of non-life insurance products including health, travel, and accident cover among others. The value of the non-life insurance market is shown in terms of gross premium incomes. Gross premium income is defined as the insurer's premium income for the year from its policies, calculated without reduction for reinsurance premiums paid or payable by the insurer.

The UK non-life insurance market had total gross written premiums of \$99.4bn in 2020, representing a compound annual growth rate (CAGR) of 2.5% between 2016 and 2020.

The motor segment was the market's most lucrative in 2020, with total gross

written premiums of \$35.8bn, equivalent to 36% of the market's overall value.

Looking forwards, the property segment of the UK non-life insurance market may benefit from the introduction of government initiatives to stimulate housing supply and encourage home ownership in the country.
