The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The non-life insurance industry within the NAFTA countries had a total market value of \$2,101.3 billion in 2022. The US was the fastest growing country, with a CAGR of 8.2% over the 2018-22 period.

Within the non-life insurance industry, the US is the leading country among the NAFTA bloc, with market revenues of \$2,021.6 billion in 2022. This was followed by Canada and Mexico, with a value of \$59.7 and \$20.0 billion, respectively.

The US is expected to lead the non-life insurance industry in the NAFTA bloc, with a value of \$3,031.1 billion in 2027, followed by Canada and Mexico with expected values of \$81.5 and \$29.1 billion, respectively.
