SUMMARY

The NAFTA Non-Life Insurance industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value 2016-20, and forecast to 2025). KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The non-life insurance industry within the NAFTA countries had a total market value of \$1,834.0 billion in 2020. The Mexico was the fastest growing country, with a CAGR of 5% over the 2016-20 period.

Within the non-life insurance industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,742.5 billion in 2020. This was followed by Canada and Mexico, with a value of \$76.5 and \$15.0 billion, respectively.

The US is expected to lead the non-life insurance industry in the NAFTA bloc, with a value of \$2,054.1 billion in 2025, followed by Canada and Mexico with expected values of \$116.3 and \$26.5 billion, respectively.
