SUMMARY

KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The non-residential construction industry within the NAFTA countries had a total market value of \$12,04,414.4 million in 2019. The US was the fastest growing country, with a CAGR of 1.3% over the 2015-19 period.

Within the non-residential construction industry, the US is the leading country among the NAFTA bloc, with market revenues of \$9,32,723.3 million in 2019. This was followed by Canada and Mexico, with a value of \$1,64,618.0 and \$1,07,073.2 million, respectively.

The US is expected to lead the non-residential construction industry in the NAFTA bloc, with a value of \$9,14,363.1 million in 2024, followed by Canada and Mexico with expected values of \$1,52,525.5 and \$98,362.2 million, respectively.
