SUMMARY

KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The non-residential construction industry within the NAFTA countries had a total market value of \$1,253.9 billion in 2020. The US was the fastest growing country, with a CAGR of 2.9% over the 2016-20 period.

Within the non-residential construction industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,007.3 billion in 2020. This was followed by Canada and Mexico, with a value of \$159.5 and \$87.1 billion, respectively.

The US is expected to lead the non-residential construction industry in the NAFTA bloc, with a value of \$1,289.0 billion in 2025, followed by Canada and



Mexico with expected values of \$218.0 and \$123.9 billion, respectively.
