SUMMARY

Sector consumption volumes declined with a negative CAGR of 1.6% between 2017 and 2022, reaching a total of 41.8 billion FTK in 2022.

The North American air freight sector has declined recently owing to several factors such as increasing interest rates and rising inflation. High-interest rates reduce access to credit for the companies involved, thereby reducing the volume of investment which negatively impacts air freight. For instance, according to the

OECD, the long-term interest rates in the US grew from 2.4% in December 2017 to 3.6% in December 2022.
