The total value of the market represents the demand for the service coming from a particular country.

The North American BPO services market had total revenues of \$94,079.6 million in 2021, representing a compound annual growth rate (CAGR) of 5.5% between 2016 and 2021.

The Vertical-specific BPO segment was the market's most lucrative in 2021, with total revenues of \$26,575.7 million, equivalent to 28.2% of the market's overall



value.

The emerging trends such as big data and analytics, cloud computing technology, and others will boost the demand for outsourcing these services by small and medium sized players as setting up these services in-house costs ample amount of money and employee training, especially when the labor costs are high across the region.
