The North American construction industry had total revenues of \$2,370.8 billion in 2021, representing a compound annual growth rate (CAGR) of 4.8% between 2016 and 2021.

The Non-Residential construction segment was the industry's most lucrative in 2021, with total revenues of \$1,246.8 billion, equivalent to 52.6% of the industry's overall value.

Decline in 2020 can be attributed to the COVID-19 pandemic which greatly impacted the North American construction market as supply chain disruptions delayed construction projects and inhibited growth in the market.
