The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The air freight industry within the NAFTA countries had a total market value of \$19,219.9 million in 2021. The US was the fastest growing country, with a CAGR of 1.1% over the 2017-21 period.

Within the air freight industry, the US is the leading country among the NAFTA bloc, with market revenues of \$17,103.2 million in 2021. This was followed by Canada and Mexico, with a value of \$1,519.1 and \$597.5 million, respectively.

The US is expected to lead the air freight industry in the NAFTA bloc, with a value of \$21,081.7 million in 2026, followed by Canada and Mexico with expected values of \$1,744.7 and \$803.5 million, respectively.
