### SUMMARY

The NAFTA Air Freight industry profile provides top-line qualitative and quantitative summary information including: sector size (value 2018-22, and forecast to 2027). ### KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The air freight industry within the NAFTA countries had a total market value of \$18,655.9 million in 2022. The US was the fastest growing country, with a CAGR of -1.8% over the 2018-22 period.

Within the air freight industry, the US is the leading country among the NAFTA bloc, with market revenues of \$16,456.5 million in 2022. This was followed by Canada and Mexico, with a value of \$1,556.1 and \$643.3 million, respectively.

The US is expected to lead the air freight industry in the NAFTA bloc, with a value of \$20,223.4 million in 2027, followed by Canada and Mexico with expected values of \$1,671.1 and \$865.4 million, respectively.
