Summary

The NAFTA Apparel Retail industry profile provides top-line qualitative and quantitative summary information including: industry size (value, and forecast to 2027). Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The apparel retail industry within the NAFTA countries had a total market value of \$460,396.3 million in 2022. The US was the fastest growing country, with a CAGR of 4.5% over the 2018-22 period.

Within the apparel retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$414,721.4 million in 2022. This was followed by Canada and Mexico, with a value of \$26,872.3 and \$18,802.6 million, respectively.

The US is expected to lead the apparel retail industry in the NAFTA bloc, with a value of \$479,132.6 million in 2027, followed by Canada and Mexico with



expected values of \$33,302.0 and \$25,695.2 million, respectively.
