The automotive aftermarket industry within the NAFTA countries had a total market value of \$190,468.7 million in 2022. The Mexico was the fastest growing country, with a CAGR of 1.6% over the 2018-22 period.

Within the automotive aftermarket industry, the US is the leading country among the NAFTA bloc, with market revenues of \$158,821.9 million in 2022. This was followed by Mexico and Canada, with a value of \$17,523.8 and \$14,123.0 million, respectively.

The US is expected to lead the automotive aftermarket industry in the NAFTA bloc, with a value of \$185,920.3 million in 2027, followed by Mexico and Canada

with expected values of \$22,718.8 and \$16,386.5 million, respectively.
