The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The automotive manufacturing industry within the NAFTA countries had a total market value of \$437.5 billion in 2022. The Mexico was the fastest growing country, with a CAGR of 0.7% over the 2018-22 period.

Within the automotive manufacturing industry, the US is the leading country among the NAFTA bloc, with market revenues of \$327.3 billion in 2022. This was followed by Mexico and Canada, with a value of \$76.1 and \$34.1 billion, respectively.

The US is expected to lead the automotive manufacturing industry in the NAFTA bloc, with a value of \$416.3 billion in 2027, followed by Mexico and Canada with



expected values of \$97.5 and \$33.5 billion, respectively.
