### Summary

The NAFTA Baby Personal Care industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2018-22, and forecast to 2027). ### Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The baby personal care industry within the NAFTA countries had a total market value of \$8,324.7 million in 2022. The US was the fastest growing country, with a CAGR of 4% over the 2018-22 period.

Within the baby personal care industry, the US is the leading country among the NAFTA bloc, with market revenues of \$7,722.5 million in 2022. This was followed by Canada and Mexico, with a value of \$541.2 and \$61.0 million, respectively.

The US is expected to lead the baby personal care industry in the NAFTA bloc, with a value of \$8,718.6 million in 2027, followed by Canada and Mexico with

expected values of \$590.7 and \$73.8 million, respectively.
