### SUMMARY

The NAFTA Banks industry profile provides top-line qualitative and quantitative summary information including: market share, industry group size (value 2017-21, and forecast to 2026). ### KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The banks industry within the NAFTA countries had a total market value of \$28,487.0 billion in 2021. The US was the fastest growing country, with a CAGR of 7.9% over the 2017-21 period.

Within the banks industry, the US is the leading country among the NAFTA bloc, with market revenues of \$22,722.7 billion in 2021. This was followed by Canada and Mexico, with a value of \$5,305.7 and \$458.6 billion, respectively.

The US is expected to lead the banks industry in the NAFTA bloc, with a value of \$29,543.4 billion in 2026, followed by Canada and Mexico with expected values of \$6,537.1 and \$647.3 billion, respectively.
