The banks industry within the NAFTA countries had a total market value of \$29,216.3 billion in 2022. The US was the fastest growing country, with a CAGR of 7.8% over the 2018-22 period.

Within the banks industry, the US is the leading country among the NAFTA bloc, with market revenues of \$22,962.7 billion in 2022. This was followed by Canada and Mexico, with a value of \$5,749.4 and \$504.2 billion, respectively.

The US is expected to lead the banks industry in the NAFTA bloc, with a value of \$29,187.5 billion in 2027, followed by Canada and Mexico with expected values of \$7,588.2 and \$693.7 billion, respectively.
