The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The bpo services industry within the NAFTA countries had a total market value of \$116,209.9 million in 2022. The Mexico was the fastest growing country, with a CAGR of 7.7% over the 2018-22 period.

Within the bpo services industry, the US is the leading country among the NAFTA bloc, with market revenues of \$103,668.4 million in 2022. This was followed by Canada and Mexico, with a value of \$8,272.4 and \$4,269.1 million, respectively.

The US is expected to lead the bpo services industry in the NAFTA bloc, with a value of \$116,153.6 million in 2027, followed by Canada and Mexico with expected values of \$10,817.2 and \$5,922.4 million, respectively.
