The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The food & grocery retail industry within the NAFTA countries had a total market value of \$2,046,138.5 million in 2022.The US was the fastest growing country, with a CAGR of 6.6% over the 2018-22 period.

Within the food & grocery retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,658,026.1 million in 2022. This was followed by Mexico and Canada, with a value of \$231,852.6 and \$156,259.8 million, respectively.

The US is expected to lead the food & grocery retail industry in the NAFTA bloc, with a value of \$1,907,536.4 million in 2027, followed by Mexico and Canada



with expected values of \$321,155.4 and \$196,826.0 million, respectively.
