Summary

Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The foodservice industry within the NAFTA countries had a total market value of \$1,125,539.7 million in 2022. The US was the fastest growing country, with a CAGR of 2.5% over the 2018-22 period.

Within the foodservice industry, the US is the leading country among the NAFTA bloc, with market revenues of \$992,136.7 million in 2022. This was followed by Canada and Mexico, with a value of \$68,917.8 and \$64,485.2 million, respectively.

The US is expected to lead the foodservice industry in the NAFTA bloc, with a value of \$1,194,120.3 million in 2027, followed by Mexico and Canada with expected values of \$103,576.5 and \$93,387.0 million, respectively.
