### Summary

The NAFTA Footwear industry profile provides top-line qualitative and quantitative summary information including: market size (value 2018-22, and forecast to 2027). ### Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The footwear retail industry within the NAFTA countries had a total market value of \$108,100.5 million in 2022. The Canada was the fastest growing country, with a CAGR of 4.2% over the 2018-22 period.

Within the footwear retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$94,577.9 million in 2022. This was followed by Canada and Mexico, with a value of \$7,352.8 and \$6,169.8 million, respectively.

The US is expected to lead the footwear retail industry in the NAFTA bloc, with a value of \$110,918.8 million in 2027, followed by Canada and Mexico with expected values of \$8,416.4 and \$7,991.7 million, respectively.
