SUMMARY

The NAFTA Fragrances industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-21, and forecast to 2026). KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The fragrances industry within the NAFTA countries had a total market value of \$8,399.7 million in 2021. The US was the fastest growing country, with a CAGR of 1.4% over the 2017-21 period.

Within the fragrances industry, the US is the leading country among the NAFTA bloc, with market revenues of \$6,844.9 million in 2021. This was followed by Mexico and Canada, with a value of \$1,040.3 and \$514.5 million, respectively.

The US is expected to lead the fragrances industry in the NAFTA bloc, with a value of \$7,987.3 million in 2026, followed by Mexico and Canada with expected values of \$1,227.9 and \$590.0 million, respectively.
