The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The functional drinks industry within the NAFTA countries had a total market value of \$35,507.2 million in 2021. The Mexico was the fastest growing country, with a CAGR of 9.4% over the 2017-21 period.

Within the functional drinks industry, the US is the leading country among the NAFTA bloc, with market revenues of \$32,059.8 million in 2021. This was followed by Mexico and Canada, with a value of \$1,887.5 and \$1,559.8 million, respectively.

The US is expected to lead the functional drinks industry in the NAFTA bloc,



with a value of \$45,222.6 million in 2026, followed by Mexico and Canada with expected values of \$2,801.9 and \$2,502.1 million, respectively.
