The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The healthcare providers industry within the NAFTA countries had a total market value of \$4,326.8 billion in 2021. The Canada was the fastest growing country, with a CAGR of 5.8% over the 2017-21 period.

Within the healthcare providers industry, the US is the leading country among the NAFTA bloc, with market revenues of \$4,016.6 billion in 2021. This was followed by Canada and Mexico, with a value of \$245.7 and \$64.5 billion, respectively.

The US is expected to lead the healthcare providers industry in the NAFTA bloc, with a value of \$5,288.5 billion in 2026, followed by Canada and Mexico with



expected values of \$318.5 and \$80.4 billion, respectively.
