The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The healthcare providers industry within the NAFTA countries had a total market value of \$4,596.7 billion in 2022. The Canada was the fastest growing country, with a CAGR of 6.5% over the 2018-22 period.

Within the healthcare providers industry, the US is the leading country among the NAFTA bloc, with market revenues of \$4,272.5 billion in 2022. This was followed by Canada and Mexico, with a value of \$254.4 and \$69.9 billion, respectively.

The US is expected to lead the healthcare providers industry in the NAFTA bloc, with a value of \$5,512.1 billion in 2027, followed by Canada and Mexico with expected values of \$326.0 and \$75.9 billion, respectively.
