SUMMARY

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The hot drinks industry within the NAFTA countries had a total market value of \$25,814.6 million in 2020. The Canada was the fastest growing country, with a CAGR of 8.8% over the 2016-20 period.

Within the hot drinks industry, the US is the leading country among the NAFTA bloc, with market revenues of \$19,531.9 million in 2020. This was followed by Canada and Mexico, with a value of \$4,136.4 and \$2,146.2 million, respectively.

The US is expected to lead the hot drinks industry in the NAFTA bloc, with a value of \$24,073.9 million in 2025, followed by Canada and Mexico with expected values of \$5,535.7 and \$2,805.2 million, respectively.
