The household products industry within the NAFTA countries had a total market value of \$79,643.4 million in 2022. The Mexico was the fastest growing country, with a CAGR of 5.1% over the 2018-22 period.

Within the household products industry, the US is the leading country among the NAFTA bloc, with market revenues of \$64,564.9 million in 2022. This was followed by Mexico and Canada, with a value of \$8,332.5 and \$6,745.9 million, respectively.

The US is expected to lead the household products industry in the NAFTA bloc,



with a value of \$68,761.6 million in 2027, followed by Mexico and Canada with expected values of \$9,881.7 and \$7,496.8 million, respectively.
