The it hardware industry within the NAFTA countries had a total market value of \$157.6 billion in 2022. The Mexico was the fastest growing country, with a CAGR of 6% over the 2018-22 period.

Within the it hardware industry, the US is the leading country among the NAFTA bloc, with market revenues of \$139.0 billion in 2022. This was followed by Canada and Mexico, with a value of \$12.0 and \$6.6 billion, respectively.

The US is expected to lead the it hardware industry in the NAFTA bloc, with a value of \$143.9 billion in 2027, followed by Canada and Mexico with expected values of \$13.8 and \$8.1 billion, respectively.
