SUMMARY

KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The it services industry within the NAFTA countries had a total market value of \$408.8 billion in 2021. The Mexico was the fastest growing country, with a CAGR of 11.6% over the 2017-21 period.

Within the it services industry, the US is the leading country among the NAFTA bloc, with market revenues of \$370.2 billion in 2021. This was followed by Canada and Mexico, with a value of \$27.6 and \$11.0 billion, respectively.

The US is expected to lead the it services industry in the NAFTA bloc, with a value of \$529.4 billion in 2026, followed by Canada and Mexico with expected values of \$39.7



and \$18.4 billion, respectively.
