The it services industry within the NAFTA countries had a total market value of \$474.3 billion in 2022. The Mexico was the fastest growing country, with a CAGR of 11.4% over the 2018-22 period.

Within the it services industry, the US is the leading country among the NAFTA bloc, with market revenues of \$415.8 billion in 2022. This was followed by Canada and Mexico, with a value of \$38.7 and \$19.7 billion, respectively.

The US is expected to lead the it services industry in the NAFTA bloc, with a value of \$623.7 billion in 2027, followed by Canada and Mexico with expected values of \$59.7 and \$35.1 billion, respectively.
