#### **SUMMARY**

The NAFTA New Cars industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2018-22, and forecast to 2027). #### **KEY HIGHLIGHTS**

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The new cars industry within the NAFTA countries had a total market value of \$488.3 billion in 2022. The US was the fastest growing country, with a CAGR of -2.4% over the 2018-22 period.

Within the new cars industry, the US is the leading country among the NAFTA bloc, with market revenues of \$439.5 billion in 2022. This was followed by Canada and Mexico, with a value of \$34.1 and \$14.7 billion, respectively.

The US is expected to lead the new cars industry in the NAFTA bloc, with a value of \$610.5 billion in 2027, followed by Canada and Mexico with expected values of \$50.3 and \$23.6 billion, respectively.
