The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The pet healthcare industry within the NAFTA countries had a total market value of \$10,048.5 million in 2022. The Mexico was the fastest growing country, with a CAGR of 7.5% over the 2018-22 period.

Within the pet healthcare industry, the US is the leading country among the NAFTA bloc, with market revenues of \$9,411.2 million in 2022. This was followed by Canada and Mexico, with a value of \$486.7 and \$150.7 million, respectively.

The US is expected to lead the pet healthcare industry in the NAFTA bloc, with a value of \$10,058.1 million in 2027, followed by Canada and Mexico with expected values of \$564.0 and \$191.3 million, respectively.
