The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The seasonings, dressings & sauces industry within the NAFTA countries had a total market value of \$41,561.4 million in 2022. The Mexico was the fastest growing country, with a CAGR of 7.2% over the 2018-22 period.

Within the seasonings, dressings & sauces industry, the US is the leading country among the NAFTA bloc, with market revenues of \$33,028.3 million in 2022. This was followed by Mexico and Canada, with a value of \$5,027.2 and \$3,506.0 million, respectively.

The US is expected to lead the seasonings, dressings & sauces industry in the

NAFTA bloc, with a value of \$38,909.1 million in 2027, followed by Mexico and Canada with expected values of \$6,645.5 and \$3,956.6 million, respectively.
