#### **SUMMARY**

The NAFTA Skincare industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-21, and forecast to 2026). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

#### **KEY HIGHLIGHTS**

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The skincare industry within the NAFTA countries had a total market value of \$21,261.3 million in 2021. The Mexico was the fastest growing country, with a CAGR of 3% over the 2017-21 period.

Within the skincare industry, the US is the leading country among the NAFTA bloc, with market revenues of \$17,853.3 million in 2021. This was followed by Canada and Mexico, with a value of \$1,766.7 and \$1,641.3 million, respectively.

The US is expected to lead the skincare industry in the NAFTA bloc, with a value of \$21,882.9 million in 2026, followed by Canada and Mexico with expected values of \$2,192.4 and \$2,040.1 million, respectively.
