#### SUMMARY

The NAFTA Software industry profile provides top-line qualitative and quantitative summary information including: market size (value 2018-22, and forecast to 2027). #### **KEY HIGHLIGHTS**

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The software industry within the NAFTA countries had a total market value of \$432.7 billion in 2022. The Mexico was the fastest growing country, with a CAGR of 10.8% over the 2018-22 period.

Within the software industry, the US is the leading country among the NAFTA bloc, with market revenues of \$384.8 billion in 2022. This was followed by Canada and Mexico, with a value of \$30.7 and \$17.3 billion, respectively.

The US is expected to lead the software industry in the NAFTA bloc, with a value of \$587.5 billion in 2027, followed by Canada and Mexico with expected values of \$50.0 and \$32.2 billion, respectively.
