SUMMARY

The NAFTA Spirits industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-21, and forecast to 2026). Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The spirits industry within the NAFTA countries had a total market value of \$129.3 billion in 2021. The US was the fastest growing country, with a CAGR of 5.1% over the 2017-21 period.

Within the spirits industry, the US is the leading country among the NAFTA bloc, with market revenues of \$109.8 billion in 2021. This was followed by Canada and Mexico, with a value of \$14.0 and \$5.6 billion, respectively.

The US is expected to lead the spirits industry in the NAFTA bloc, with a value of \$137.6 billion in 2026, followed by Canada and Mexico with expected values of \$17.1 and \$7.7 billion, respectively.
