The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The sports equipment retail industry within the NAFTA countries had a total market value of \$70,430.3 million in 2022.The Canada was the fastest growing country, with a CAGR of 11.7% over the 2018-22 period.

Within the sports equipment retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$63,347.1 million in 2022. This was followed by Canada and Mexico, with a value of \$6,555.3 and \$528.0 million, respectively.

The US is expected to lead the sports equipment retail industry in the NAFTA bloc, with a value of \$69,153.6 million in 2027, followed by Canada and Mexico



with expected values of \$7,572.8 and \$729.5 million, respectively.
