The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The telecommunication services industry within the NAFTA countries had a total market value of \$378.8 billion in 2022. The Mexico was the fastest growing country, with a CAGR of 4.4% over the 2018-22 period.

Within the telecommunication services industry, the US is the leading country among the NAFTA bloc, with market revenues of \$322.0 billion in 2022. This was followed by Canada and Mexico, with a value of \$37.4 and \$19.4 billion, respectively.

The US is expected to lead the telecommunication services industry in the



NAFTA bloc, with a value of \$376.0 billion in 2027, followed by Canada and Mexico with expected values of \$41.3 and \$24.3 billion, respectively.
