SUMMARY

The tobacco & tobacco products industry within the NAFTA countries had a total market value of \$120.9 billion in 2021. The US was the fastest growing country, with a CAGR of 0.5% over the 2017-21 period.

Within the tobacco & tobacco products industry, the US is the leading country among the NAFTA bloc, with market revenues of \$104.3 billion in 2021. This was followed by Canada and Mexico, with a value of \$10.9 and \$5.7 billion, respectively.

The US is expected to lead the tobacco & tobacco products industry in the



NAFTA bloc, with a value of \$104.7 billion in 2026, followed by Canada and Mexico with expected values of \$12.5 and \$6.7 billion, respectively.
