The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The tobacco & tobacco products industry within the NAFTA countries had a total market value of \$123,553.7 million in 2022. The US was the fastest growing country, with a CAGR of 0.7% over the 2018-22 period.

Within the tobacco & tobacco products industry, the US is the leading country among the NAFTA bloc, with market revenues of \$107,149.6 million in 2022. This was followed by Canada and Mexico, with a value of \$10,506.8 and \$5,897.3 million, respectively.

The US is expected to lead the tobacco & tobacco products industry in the



NAFTA bloc, with a value of \$109,510.6 million in 2027, followed by Canada and Mexico with expected values of \$10,354.8 and \$6,562.5 million, respectively.
