The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The toys & games retail industry within the NAFTA countries had a total market value of \$38,019.2 million in 2022. The Canada was the fastest growing country, with a CAGR of 11.3% over the 2018-22 period.

Within the toys & games retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$32,763.9 million in 2022. This was followed by Canada and Mexico, with a value of \$2,938.5 and \$2,316.8 million, respectively.

The US is expected to lead the toys & games retail industry in the NAFTA bloc, with a value of \$37,182.8 million in 2027, followed by Mexico and Canada with



expected values of \$2,912.0 and \$2,891.0 million, respectively.
