The transportation services industry within the NAFTA countries had a total market value of \$708,494.8 million in 2021. The Mexico was the fastest growing country, with a CAGR of 5.4% over the 2017-21 period.

Within the transportation services industry, the US is the leading country among the NAFTA bloc, with market revenues of \$573,893.6 million in 2021. This was followed by Mexico and Canada, with a value of \$72,293.9 and \$62,307.3 million, respectively.

The US is expected to lead the transportation services industry in the NAFTA bloc, with a value of \$766,534.3 million in 2026, followed by Mexico and Canada

with expected values of \$84,492.2 and \$76,447.5 million, respectively.
