SUMMARY

The Norwegian metals & mining industry had total revenues of \$7,066.8 million in 2022, representing a compound annual growth rate (CAGR) of 18.4% between 2017 and 2022. In comparison, the Swedish industry increased with a CAGR of 10.5%, and the German industry increased with a CAGR of 12.5%, over the same period, to reach respective values of \$26.9 billion and \$85.6 billion in 2022.

Production volume increased with a CAGR of 6% between 2017 and 2022, to reach a total of 4.9 billion metric ton in 2022. The 's volume is expected to rise to 5.1 billion metric ton by the end of 2027, representing a CAGR of 0.9% over 2022-2027 period.
