Oil & Gas in Brazil

Summary

Oil & Gas in Brazil industry profile provides top-line qualitative and quantitative summary information including: market size (value 2018-23, and forecast to 2028). Key Highlights

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country. The value of the oil segment reflects the total volume of refined petroleum products, including refinery consumption and losses, multiplied by the average retail price of gasoline and diesel taken together. The value of the gas segment is calculated as the total volume of natural gas consumed multiplied by the retail price of natural gas.

The Brazilian oil & gas market recorded revenues of \$141.4 billion in 2023, representing a negative compound annual growth rate (CAGR) of 2.9% between 2018 and 2023.

Market consumption volumes declined with a negative CAGR of 3.4% between 2018 and 2023, to reach a total of 974.3 million BoE in 2023.

The contraction in the oil & gas market in recent years can be attributed to the growing sales of electric vehicles. According to MarketLine, the Brazilian hybrid

and electric cars market stood at \$1.1 billion in 2023, an increase of 6.8% from the previous year.
