## Abstracts

Oil and Gas in Egypt

### SUMMARY

Oil & Gas in Egypt industry profile provides top-line qualitative and quantitative summary information including: market size (value 2015-19, and forecast to 2024). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

### KEY HIGHLIGHTS

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country.

The Egyptian oil and gas market had total revenues of \$20.0bn in 2019, representing a compound annual growth rate (CAGR) of 2.8% between 2015 and 2019.

Market consumption volume increased with a CAGR of 1.4% between 2015 and 2019, to reach a total of 626.6 million BoE in 2019.

Consumption in the Egyptian market declined by 3.1% in 2019, driven down by a decline in the domestic production of oil, with costlier imports inflating oil prices, eventually reducing demand.
