Oil & Gas in Hong Kong

Summary

Oil & Gas in Hong Kong industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2018-23, and forecast to 2028). Key Highlights

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country. The value of the oil segment reflects the total volume of refined petroleum products, including refinery consumption and losses, multiplied by the average retail price of gasoline and diesel taken together. The value of the gas segment is calculated as the total volume of natural gas consumed multiplied by the retail price of natural gas.

The Hong Kongese oil & gas market recorded revenues of \$66.4 billion in 2023, representing a compound annual growth rate (CAGR) of 9.1% between 2018 and 2023.

Market consumption volume increased with a CAGR of 0.5% between 2018 and 2023, to reach a total of 180.4 million BoE in 2023.

The slow growth in the oil & gas market in 2023 can be attributed to the growing sales of electric vehicles. According to MarketLine, the Hong Kongese hybrid

and electric cars market stood at \$3.5 billion in 2023, an increase of 13.4% from the previous year.
